3. Receive and Adopt Annual Accounts for Year Ended February 2015
The accounts have not yet been audited.

Total income for the year was £5,180 and expenditure totalled £17,407, which was mainly attributed to hall repairs undertaken with the Big Lottery grant money.

The balance on the Current Account stands at £3,432, with the Deposit Account totalling £15,215. This is down on last year due to £3,000 being borrowed temporarily in order to keep us afloat until we receive the WREN grant money. The balance on the 200 Club account is currently £130. Because of the timing of the Lottery Grant award for £10,000 in 2014 which was deemed as income in last year's accounts, we are showing an overall loss of income in 2014/15 on last year of £12,226.

Total overspend in the year was £4,701, which was made up of a £1,756 overspend on the Lottery Grant, due to Hall repairs, plus £2,945 which we have had to pay as a deposit to WREN, which we will get back once the work is completed, but in accounting terms is expressed as an overspend.

Regarding revenue, the 200 Club was £1,075. Hall and Equipment Hire was £1,896, which is down slightly on the previous year, mainly due to the hall closures for work to take place. Special events raised £2,200 versus £2,800 the previous year.

Overall Hall expenses were £1,300 versus £1,700 last year. Water costs were down slightly at £468 versus £543 and electricity costs were £120 cheaper than the previous year.

Going forward, draft accounts to be distributed to Committee Members prior to the meeting and at the discretion of the Treasurer.
